PRODUCT DESCRIPTION

Lucas #1025 Alkyd Metal Primer is an oil-based coating intended for application to rusty metal roofs and rooftop equipment prior to application of Lucas elastomeric roof coatings. Also recommended for rust-proofing rusty metal roof decks when re-roofing.

Lucas #1025 is manufactured from a short oil alkyd base, quick drying solvents and rust inhibiting pigments. It is manufactured to a light gray color.

APPLICATION

The surface to be coated must be clean and dry. Apply #1025 at a rate of 3/4 to 1 gallon per 100 square feet with a suitable roller, airless spray or soft bristle brush. Do not over-apply or allow coating to pool. Do not topcoat until coating is fully cured. Clean up with mineral spirits.

Clean up: Lucas #125 Safe Solve™.

Shelf Life: one year from the date of manufacture.
