### PRODUCT DESCRIPTION

Lucas #116 is a powerful plant ester derived paint graffiti remover. It is biodegradable, water soluble and has a very slow evaporation rate. Effective on all types of oil based spray paint. Will not harm factory finished metals including metal wall panels, garage doors, aluminum siding etc. Will stain masonry surfaces. Stains may be removed with Lucas #117 Oil & Grease Spot Remover.

### APPLICATION

For general cleaning, remove as much of the material to be treated as possible before applying this product. Test in an inconspicuous area prior to use. Apply to surface, allow sitting for at least one hour then power wash or scrub with a soft bristle brush. Repeat as necessary. Rinse area with plain water to remove oily residue.

95% of residual applied cleaner will evaporate or bio-degrade within 28 days. This product may alter the appearance of vinyl siding with a chalky or porous surface and may permanently stain siding if not rinsed off. Tools may be soaked overnight to remove heavy residues of asphalt. Acrylic paint and caulk will be softened allowing for easier removal. Do not apply to painted surfaces.

Clean up: Clean up with water.

Shelf Life: Two years from the date of manufacture.
