#2100 SPECIFICATION

PRODUCT DESCRIPTION

Lucas #2100 Block Filler is a water-based acrylic coating designed to fill pits and capillaries in concrete block walls prior to coating with Lucas #2000 Elastomeric Wall Coating.

#2100 is manufactured from a blend of acrylic binder and mineral filler that produces a strong and impermeable aggregate that will fill holes and prevent air pockets from producing openings in the coating film.

APPLICATION

Mechanically mix before using. Do not store above 90°F. Apply only at temperatures above 40°F and rising with less than 90% humidity and no threat of rain for 48 hours.

Apply with a roller or suitable spray equipment at the rate of 1-2 gallons per 100 sq. ft. per coat. For spray applications back rolling is required. Drying time to top coat @ 70°F is 2 to 4 hours

Clean up: Soap and water (wet coating).

Shelf Life: One year from the date of manufacture
