#### PRODUCT DESCRIPTION

Lucas #5025 Roof Prep is a fast-drying solvent cleaner intended for cleaning all types of roofs prior to repairing with Lucas repair products, tapes or membranes. #5025 is also used as a splice wash for preparing seam areas of single-ply roofing membranes for bonding. #5025 is compatible with all types of roofs.

Lucas #5025 is 100% pure refined aliphatic hydrocarbon and VOC exempt ketone solvent with a fast evaporation rate. #5025 is a low VOC formula.

#### APPLICATION

Apply #5025 to the seam area with a clean rag or aerosol spray. Wipe the area until all surface contamination is removed. Allow the #5025 to dry completely before bonding the seam or applying any type of Lucas repair product. Dry time will vary but is generally five to ten minutes.

Clean up: NA

Shelf Life: Two years from the date of manufacture.
