#215 SPECIFICATION

PRODUCT DESCRIPTION

Lucas #215 Form Oil is intended for application to all types of concrete forms to aid in their removal and to help eliminate surface voids. Also prevents buildup of concrete mix on tools and equipment.

#215 is a blend of non-staining natural oils that react to form a soapy interface between the surface of the form and the concrete.

APPLICATION

Apply #215 by brush, roller or spray immediately prior to pouring the concrete. See below for recommended rates of application.

1000-1500 sq. ft. per U.S. gallon

Medium Density Plywood:
1000 sq. ft. per U.S. gallon

BB Grade Plyform:
1000 sq. ft. per U.S. gallon

600 sq. ft. per U.S. gallon

Lucas #125 Safe Solve™.

Two years from the date of manufacture.
