PRODUCT DESCRIPTION

Lucas #1020 Acrylic Resin Primer is a single component polymer emulsion resin intended as a general-purpose primer to prepare substrates for the application of elastomeric coatings and sprayed polyurethane foam. #1020 is black in color, can be applied by spray, brush or roll and provides excellent adhesion to most surfaces. #1020 may be used on metal, wood, concrete (fully cured), modified bitumen and asphalt BUR roofs. #1020 may also be used as a primer for unparged CMU, masonry and EIFS walls. Its black color can promote faster drying.

APPLICATION

Mechanically mix before using. Do not store above 90°F. Apply only at temperatures above 40°F and rising with less than 90% humidity and no threat of rain for 48 hours. Surfaces can be power washed clean with Lucas #115. The surface may be damp but must be free of standing water.

Apply with a soft bristle brush, roller or suitable spray equipment at the rate of 1/2 gallon per 100 sq. ft. More will be required on alligatored or irregular surfaces.

Application over primer should occur within 48 hours for best adhesion performance.

When applied to areas that retain water more than 48 hours service life will be severely diminished and adhesion failure can be expected.
